Call to Order

Mayor Gaddy called the meeting to order at 6:15 p.m.

Invocation

Mayor Gaddy offered the Invocation.

Approval of Minutes

Councilman McMeekin made a motion with a second by Councilwoman Bartell-Prather that the minutes of the September 19, 2017, Finance Meeting and Town Council Meeting be approved as written. All voted aye.


Questions from Media – None
