The Town of Winnsboro, SC is currently soliciting bids for the Town of Winnsboro Jackson Creek WWTP Generator. The scope of work for this project includes the following:

- Installation of a generator and all required electrical infrastructure
- Installation of concrete pads for a new generator and automatic transfer switch
- Installation of new gravel drive
- Installation of erosion control facilities
- Demolition of existing site conditions

Each prospective bidder must meet the following qualifications and bid requirements:

- Satisfactory completion of a minimum of five (5) similar projects in the State of South Carolina within the last 10 years. Similar project includes wastewater treatment facility improvements, above/below ground concrete structures, and associated electrical improvements.
- Provide a minimum of three (3) references of past clients familiar with work on similar projects.
- Deposit bid security in the amount and form specified in the Instructions for Bidders.
- Comply with all federal, state, and local regulations, as outlined in the front-end documents.

Separate sealed bids for the Town of Winnsboro Jackson Creek WWTP Generator will be received at Winnsboro Town Hall 207 N Congress St. Winnsboro, SC 29180. The bid opening will occur at the Winnsboro Town Office, on Tuesday, December 5, 2023 at 2 PM. At this time, the bids will be publicly opened and read aloud. Each bidder must deposit security in the amount and form specified in the Information for Bidders.

This project is being funded in whole or in part by the Community Development Block Grant Program (CDBG). All federal CDBG requirements and special contract provisions (Attachment E) will apply to this project. **All Contractors and subcontractors are required to be registered in the federal System for Award Management (SAM) database.** Bidders on this work will be required to comply with the President's Executive Order No. 11246 & Order No. 11375 which prohibits discrimination in employment regarding race, creed, color, sex, or national origin.

Bidders must also make positive efforts to use small and minority-owned businesses and to offer employment, training and contracting opportunities in accordance with Section 3 of the Housing and Urban Development Act of 1968. The grant period for the project is July 2022 through July 2024.
